Fresh flowers and plant material – Accessories allowed
Not to exceed 25.5 cm in height

4 A. ONE FLOWER ARRANGEMENT
Arrangement using a single fresh flower

Novice – Not to have won a first in any section of the Competition at Division or State level.
Arrangement using a single fresh Flower
No truss or spike

5 A. FRESH MINIATURE ARRANGEMENT
Fresh Materials
Not to exceed height or width of 7.5cm

5 B. DRIED MINIATURE ARRANGEMENT
Horticultural materials only (May be coloured)
Not to exceed height or width of 7.5cm
Sponsored by QCWA Border Division

6. ARRANGEMENT WITH FIVE ARTIFICIAL FLOWERS
No fresh plant materials. Artificial materials allowed - no berries or additional small flowers
(A bud is only counted as a flower if it is open or shows colour)

7. SUCCULENTS BY THE SEASIDE
Succulent flowers permitted
Dried material and accessories allowed

No truss or spike. No fresh plant materials.
Artificial materials allowed – no berries or additional small flowers.

9. ARRANGEMENT WITH HORTICULTURAL MATERIAL INCORPORATING PRODUCT OF THE YEAR.
PUMPKIN to be prominent.

CHAMPION ARRANGEMENT

IMPORTANT: COMPETITORS AND JUDGES SHOULD USE THE FOLLOWING CRITERIA IN CONJUNCTION WITH THE SCHEDULE.

No arrangement or base to exceed 50cm in width. Miniatures 7.5cm.

No height restriction except where stated in the schedule.

No accessories or drapes allowed except where stated in the schedule.

In all sections, except Table, Foliage and Artificial dried horticultural material may be used to enhance the arrangement.

For the QCWA contest 'One Flower'; a protea, strelitzia (bird of paradise) or an anthurium which is classed as a bract will be accepted.

Fresh plant material should have the cut end in water or water retaining material unless it will remain turgid for the length of the competition. Ribbons are not permitted.

Care needs to be taken to ensure arrangements are leak proof and easily moved.

An arrangement may lose points if it does not comply with the schedule.

The judge's decision is final.

ENTRY FEE (paid at Branch level only) is 50 cents.

The 1st prize winner at Branch level proceeds to Division level, 1st prize winner at Division proceeds to State Contest Finals. If the first place winner cannot go on to Division or State level, the second place winner is eligible to compete.
