



Mrs Audrey Jean Hoskin (previously QCWA Cooranga North Branch) had a great love of music. She passed away on Anzac Day 1955. The four (4) beneficiaries of Mrs Hoskins' estate have very generously agreed to contribute equally to a fund to help support financially, by way of a perpetual annual bursary scheme, young country people in their musical endeavours, and thus commemorate their aunt's name. The beneficiaries are Mrs Jean D'Arth (nee Gray), Edward and Allan Gray and Mrs Patricia Gaudry (nee Coe).

The criteria for the bursary:

- **Audrey J Hoskins Music Bursaries** (each \$1,000 per annum) are offered annually to students who are dedicated to the pursuit of a musical career (either vocal or instrumental) and have planned programs of study accordingly.
- Applicants must have achieved a standard of excellence that would permit their entry to an accredited school of music (for example, the Queensland Conservatorium). They should intend to pursue study either at the Conservatorium or under the tutelage of a recognised Queensland private teacher.
- Both male and female students may apply. The bursaries are intended to enable talented students who might be denied the opportunity, through financial stringency, to enter, or continue in a course of music studies. Applicants from rural backgrounds will have some competitive advantage.

Applications must provide:

1. Details of music examination results and the teacher under whom they last studied.
2. An evaluation of the student's ability and potential to progress in a music career (send to [secretary@qcwa.org.au](mailto:secretary@qcwa.org.au)) from their music teacher/tutor.
3. Demonstrated need for financial support
4. Three (3) current character references
5. Outline of proposed study
6. Short (500 word) statement of achievements and future aspirations in the music area.

At the end of any year of support, a bursary may be awarded for the duration of the course provided the bursary recipient is progressing in their course in a fully satisfactory manner and makes the necessary application for review. The QCWA reserves the right to limit the time that any one student holds a bursary.

QCWA will arrange a presentation function for the bursary and recipients will be asked to attend. Family and friends are welcome to attend.

As part of the **Audrey J Hoskin Bursary**, recipients may be asked to assist the Association by volunteering their time and skills to special events or projects.
